### **4.Stipend:**

- 1) The Undergraduate/graduate and post graduate Interns shall be paid a consolidated stipend of Rs.10000/- and Rs. 15000/- respectively for the entire duration of the Internship.
- 2) The stipend shall be payable by the MCRJN allotted organisation after the completion of Internship.subject to satisfactory performance, duly certified by the Supervisor/Mentor.
